Our Child Safe Statement encompasses the following commitments:

Child Safety Commitment:

Our dedicated staff members receive comprehensive training, resources, and support to fulfill their duty of care effectively. We continuously assess and address potential risks to ensure a safe and secure environment. We actively encourage open communication, listening attentively to children, families, and the wider community, and respond promptly and compassionately to any concerns or feedback.

Cultural Safety Commitment:

We wholeheartedly acknowledge and deeply respect the cultural heritage, diversity, and unique needs of Aboriginal children and children from diverse backgrounds. We are committed to promoting cultural safety by fostering an environment that appreciates, respects, and celebrates different cultures, traditions, and languages.

We provide culturally appropriate learning experiences that honour Aboriginal cultures and the diverse backgrounds of our children and families. Discriminatory practices have no place within our community, and we strive to cultivate an atmosphere that promotes inclusivity, respect, and acceptance for all.

Safe Environment for Children with Disabilities:

We are resolute in providing a safe and inclusive environment for children with disabilities. We are committed to accommodating the individual needs of each child, ensuring equal access to our programs and facilities. We work closely with families and relevant professionals to implement tailored support and accommodations, fostering a sense of belonging, empowerment, and participation.

United Nations Convention on the Rights of the Child:
